**PRIOR TO SCHEDULING AN INSPECTION, PLEASE READ THE FOLLOWING:**

1. Prior to scheduling an inspection three (3) sets of stamped plans and one (1) digital set must be submitted for review. Plan review instructions are below.
2. Fire inspections will be conducted on Wednesdays during normal city business hours unless prior arrangements have been made. Inspections outside of regular business hours will include an after-hours fee.
3. All building fire systems are required to have a current approved annual inspection tag at the time of inspection. Outdated or red/yellow tagged systems will result in a failed C.O. inspection. Please verify with the building owner that these are current prior to calling for a final inspection. All commercial occupancies require an addressable monitored fire alarm system.
4. Provide keys to your space at the C.O. inspection to be secured in the building's Knox Box.
5. Exit doors must have approved hardware.
6. Fire extinguishers must be mounted in approved locations and have current inspection tags.
7. Extension cords are not allowed as a substitute for permanent wiring.
8. Fire lanes must be in good condition and repainted if needed.
9. This space is **NOT** to be occupied, stocked, or used for storage prior to the written approval from the City of Krum's building official and fire prevention office. Contact us if needed.

11. An inspection is **NOT** scheduled until you are contacted by the fire prevention office.

I confirm and acknowledge that all the information listed in this application is complete and true. I understand that at any time conditions are unsafe or not in compliance with the listed conditions or conditions on-site become unsafe, that any permit if issued, can be revoked by the City of Krum. A completed application is not a permit, nor is it conditional that a permit is issued. All fees shall be paid prior to the work and in full. I/company shall maintain our own insurance and coverage assuming all liabilities potential and unknown. If work begins without a valid permit, the permit fees are doubled. I also understand that this application is not inclusive and other permits may be required by other departments and entities. An issued permit becomes <b>INVALID</b> if the approved work does not begin on-site within 180 days of issuance or if the work on-site is not completed 180 days after it begins due to suspension or abandonment. <b>ALL PERMITS REQUIRE A FINAL INSPECTION AND/OR A CERTIFICATE OF OCCUPANCY.</b></p>

Effective October 12, 2022, the Krum Fire Marshal's Office will be utilizing third-party plan review services to supplement our plan review process. Please submit your plans to one of the approved firms below. This will ensure that the plan review procedure is completed as quickly and efficiently as possible. The submitted plans must bear the stamp and signature of both the third-party review firm and the contractor's design professional. The contractor, owner, or designated agent must pay the third-party review fees and related expenses in full and directly to the third-party firm.

### Steps for Plans Requiring 3rd Party Review:

**STEP 1-** Submit your plans to a selected third-party firm from our approved list (See Below). The firm shall represent a Texas-licensed professional engineer with a license in the branch of fire protection.

**STEP 2-** Submit the following items to the Krum Fire Marshal's Office for permit approval.

- A completed Krum Fire Marshal's Permit Application (available at <https://www.krumfire.com/permits-inspections>)
- A completed contractor registration application.
- Copies of all state-issued licenses.
- Submit three (2) paper copies and one (1) electronic copy (PDF) of reviewed plans and all associated documents. Submitted plans shall bear the stamp and signature of both the third-party firm and the contractor's design professional.
- Send all documents to Krum Fire Department located at 400 N First St Krum, TX 76249, or email at [kfdprevention@krumfire.com](mailto:kfdprevention@krumfire.com). If you need any assistance please call 940-482-6257.

**STEP 3-** After the required documents have been submitted in the appropriate format, the Krum Fire Marshal's Office will issue a permit after receiving, reviewing, and approving. A copy of the stamped approved plans and your permit will be emailed or available for pick up.

\* Inspections will not be scheduled until all documentation requirements are satisfied. Please Note: The final fire and life safety inspection with the General Contractor shall not be scheduled until all related documents listed above are on file with the Krum Fire Marshal's office.
