### CITY OF KRUM, TEXAS

#### **ORDINANCE NO. 2022-746**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KRUM, TEXAS AMENDING ARTICLE A6.000, "FIRE INSPECTION, ALARM, AND SPRINKLER PERMIT FEES," OF APPENDIX A, "FEE SCHEDULE," OF THE KRUM CODE OF ORDINANCES; PROVIDING A CUMULATIVE REPEALER CLAUSE; PROVIDING FOR SAVINGS; PROVIDING SEVERABILITY; PROVIDING A PUBLICATION CLAUSE; PROVIDING FOR ENGROSSMENT AND ENROLLMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Krum, Texas, is a Home Rule Municipality located in Denton County, Texas, created in accordance with provisions of the Texas Local Government Code the Texas Constitution and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, the City Council has adopted Appendix A of the Code of Ordinances which establishes a fee schedule for the City of Krum to recapture expenses for the review and processing of permits for the Fire Department; and

WHEREAS, the City Council has further determined that amendment of Appendix A is necessary to be the most equitable means of cost recovery for the services of the Fire Department; and

WHEREAS, after due deliberation and consideration of the information submitted with the city staff recommendations, the City Council has concluded that the adoption of this Ordinance is in the best interest of the health, safety, and welfare of the citizens of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KRUM, TEXAS;

# SECTION 1 INCORPORATION OF PREMISES

The above and foregoing premises are true and correct and are incorporated herein and made a part hereof for all purposes.

### SECTION 2 FINDINGS

After due deliberations, the City Council has concluded that the adoption of this Ordinance is in the best interest of the City of Krum, Texas, and of the public health, safety and welfare. The City Council further finds that the proposed ordinance has been designed, with respect to both present conditions and the conditions reasonably anticipated to exist in the foreseeable future to

facilitate and balance the need for economic activity, development, serenity, health property rights and the enjoyment of land.

# SECTION 3 AMENDMENTS

3.01 That the Krum City of Ordinances amending Article A6.000, "Fire Inspection, Alarm, and Sprinkler Permit Fees," of Appendix A, "Fee Schedule," of the Krum Code of Ordinances is hereby amended to read as follows:

"Article A6.000 FIRE INSPECTION, ALARM, AND SPRINKLER PERMIT FEES

All permits shall be obtained from the Fire Marshal's Office prior to engaging in the following activities, operations, practices, functions, or construction. Permits will not be issued unless the approved plans, applications, and fees have been submitted.

- 3.02 All other articles, chapters, sections, paragraphs, sentences, phrases, and words are not amended but are hereby ratified and affirmed.

## SECTION 4 CUMULATIVE REPEALER CLAUSE

This Ordinance shall be cumulative of all other Ordinances and shall not repeal any of the provisions of such Ordinances except for those instances where there are direct conflicts with the provisions of this Ordinance. Ordinances, or parts thereof, in force at the time this Ordinance shall take effect and that are inconsistent with this Ordinance are hereby repealed to the extent that they are inconsistent with this Ordinance. Provided however, that any complaint, action, claim or lawsuit which has been initiated or has arisen under or pursuant to such other Ordinances on the date of adoption of this Ordinance shall continue to be governed by the provisions of such Ordinance and for that purpose the Ordinance shall remain in full force and effect.

# SECTION 5 SAVINGS CLAUSE

All rights and remedies of the City of Krum, Texas are expressly saved as to any and all violations of the provisions of the City's Code of Ordinances or of any other ordinance affecting offenses and nuisances, which have been secured at the time of the effective date of this Ordinance; and, as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances same shall not be affected by this Ordinance but may be prosecuted until final disposition by the court.

## SECTION 6 PENALTY

It shall be unlawful for any person to violate any provision of this Ordinance, and any person violating or failing to comply with any provision hereof shall be fined, upon conviction, in an amount not more than Two Thousand Dollars (\$2,000.00), and a separate offense shall be deemed committed each day during or on which a violation occurs or continues.

## SECTION 7 SEVERABILITY

The provisions of this Ordinance are severable. However, in the event this Ordinance or any procedure provided in this Ordinance becomes unlawful, or is declared or determined by a judicial, administrative or legislative authority exercising its jurisdiction to be excessive, unenforceable,

void, illegal or otherwise inapplicable, in whole or in part, the remaining and lawful provisions shall be of full force and effect and the City shall promptly promulgate new revised provisions in compliance with the authority's decision or enactment.

## SECTION 8 PUBLICATION

The City Secretary of the City of Krum is directed to publish in the official newspaper of the City, the caption, and effective date of this Ordinance as required by law.

## SECTION 9 ENGROSSMENT AND ENROLLMENT

The City Secretary is hereby directed to engross and enroll this Ordinance by copying the exact Caption and Effective Date clause in the minutes of the City Council and by filing this Ordinance in the Ordinance records of the City of Krum, Texas.

### SECTION 10 EFFECTIVE DATE

This Ordinance shall become effective from and after its date of passage in accordance with law.
